

Our goal is to provide information that will assist you in getting to know the candidates so that you can make an informed choice when you cast your vote on or before Election Day.

If you will be unable to vote at your designated polling place on Election Day you may vote absentee by mail, by fax or in-person, more information is provided throughout the voter pamphlet. Apply online for an absentee ballot by mail or by fax at www.my.kpb.us/vote.



# **General Voter Information**

# **Voter Qualifications**

A person qualified to vote in a borough-wide election is:

- a citizen of the United States
- at least 18 years of age
- a resident for at least 30 days of the borough and the precinct,
   Assembly/Board of Education district and/or service area in which voting
- registered to vote at a residence address within the borough at least
   30 days before the election

Your voter registration record is important. Please keep it current by contacting your Regional Election Supervisor, the Borough Clerk's Office, or your City Clerk's Office when making changes of name, address or party affiliation.

A. Precincts where the voter turnout was less than 200 voters at the last regular election may be designated as "absentee by-mail" precincts by resolution of the assembly. In those precincts, no election workers shall be appointed. The procedures outlined in Chapter 4.120 shall be followed with the following exceptions: 1. that ballots shall be sent to each registered voter in the precinct on or before the 15th day prior to the election; and 2. that voted ballots must be postmarked on or before midnight of election day and received by the clerk no later than the Tuesday following the election.

B. Voters wishing to vote absentee in person may do so at any designated absentee voting site.

C. Any precinct designated as an "absentee by-mail" precinct in accordance with the provisions of subsection A, above, will remain an "absentee by-mail" precinct until such time as the "absentee by-mail" status is removed by resolution of the assembly.

# **Absentee By-Mail Precincts**

KPB 4.50.015. Absentee by-mail precincts.

- A. Precincts where the voter turnout was less than 200 voters at the last regular election may be designated as "absentee by-mail" precincts by resolution of the assembly. In those precincts, no election workers shall be appointed. The procedures outlined in Chapter 4.120 shall be followed with the following exceptions: 1. that ballots shall be sent to each registered voter in the precinct on or before the 15th day prior to the election; and 2. that voted ballots must be postmarked on or before midnight of election day and received by the clerk no later than the Tuesday following the election.
- B. Voters wishing to vote absentee in person may do so at any designated absentee voting site.
- C. Any precinct designated as an "absentee by-mail" precinct in accordance with the provisions of subsection A, above, will remain an "absentee by-mail" precinct until such time as the "absentee by-mail" status is removed by resolution of the assembly.

If you are registered to vote in one of these six (6) precincts, you will automatically be mailed a ballot by the Borough Clerk's Office approximately 2 weeks prior to the election. Included with your ballot will be instructions for voting a by-mail ballot, a secrecy sleeve for your voted ballot, and a mailing envelope for returning your voted ballot to the Borough Clerk's Office. This return envelope has been designed to protect any confidential information.

- Step 1. Vote ballot.
- Step 2. Place voted ballot in the secrecy sleeve and return envelope.
- Step 3. Write in ONE Identifier in the space provided and sign the envelope.

  Write ONE of the specified identifiers in the space provided on the envelope [date of birth, last four digits of your social security number or voter identification number] and sign the return envelope in front of a witness.
- Step 4. Have your signature witnessed by someone over 18 years of age or older or an authorized official. [Notary Public, commissioned officer of the armed forces, district judge or magistrate, registration official or other person qualified to administer oaths. KPB 4.80.070(C)]
- Step 5. Seal the return envelope and mail your ballot to the Borough Clerk's Office. [MUST be postmarked on or before election day, Tuesday, October 3, 2023.]

### General Information

- 1. You may apply for absentee ballots for any or all elections conducted by the Borough within the calendar year 2023, as long as the ballots for each election will be sent to you at the same address.
- 2. If you will be in the Kenai Peninsula Borough within 15 days before an election, you may prefer to vote ABSENTEE IN PERSON. Check with the Borough Clerk's Office for locations throughout the Borough.

### Instructions

- Apply early to be sure you receive your ballot in time.
- Complete ALL information requested. It is required by law. Omissions will result in your application being rejected.
- You must provide your residence address in the Kenai Peninsula Borough. Use the
  description of the physical location street number, trailer court and space number,
  etc. (Please note: If you give a residence address in another state or country, or use a
  P.O. Box, PSC or Rural Route Number instead of a physical address, your application
  will be rejected.)

Notice to active duty military personnel: To remain registered in Alaska you must be an Alaskan resident and provide your physical residence address within the State. If you have been assigned to an active duty station outside Alaska, you may wish to maintain your Alaskan residence address as it appears on your current registration record. If you provide a new residence address, it must be within Alaska.

Sign your application. A friend, spouse or parent may not sign for you.



# **By-Mail Voting Instructions**



### 1. Vote Ballot

- Fill in the oval next to your choices using a blue or black pen.
- For elections that allow write-in candidates, print the person's name on the blank line and fill in the oval next to the name you have written.
- Follow the instructions on the ballot for voting on your ballot.
- If you make a mistake voting, call the Borough Clerk's office listed below to
  request a replacement ballot or draw a line through the oval and candidate or
  proposition you voted, write "no" next to it and then continue voting by filling in
  the oval next to your choice.

### 2. Place Ballot Inside the Return Ballot Envelope

- Refold your ballot and place it inside the secrecy sleeve.
- Place sleeve with your ballot inside the return ballot envelope.




### 3. Provide ONE Identifier in the space provided and sign the envelope

- Write ONE of your identifiers on the back of the envelope:
  - Voter number, date of birth or last four of your SSN.
- Sign your Return Ballot Envelope in front of your witness.



### 4. Have your Signature Witnessed

- Have your signature witnessed by an \*authorized official or, if no official is reasonably available, by someone 18 years of age or older.
  - \* Authorized officials: Notary public, commissioned officer of the armed forces, district judge or magistrate, registration official or other person qualified to administer oaths.



# 5. Seal the Return Envelope and Mail Your Ballot to the Borough Clerk's Office

- Fold over the flap of the return envelope to cover up your signature, identifier and witness information. Peel and seal it at the top and bottom.
- Mail your ballot. It MUST be **POSTMARKED** on or before Election Day, Tuesday October 3, 2023.



# **Voter Rights/Assistance While Voting**

The following information explains basic voting rights and will help voters with special needs.

### **Visually-Impaired Voters**

A touch screen voting unit will be in each polling place on Election Day and at each absentee in person voting site. Touch screen voting is intended for the blind, disabled and voters with reading difficulties.

The touch screen voting units allow disabled voters to vote unassisted through the use of a magnified, high contrast and audio ballot.

At the end of voting, a voter-verifiable paper ballot is produced by the touch screen unit. This paper print-out is secured behind a screen and allows the voter to verify the electronic ballot for accuracy.

If you need to vote using a touch screen unit, ask an election worker for this voting option.

# **Assistance While Voting**

If you have difficulty voting because of a physical disability or handicap, difficulty reading or writing English, or need any other type of assistance, you may bring someone to help you at the polls. The person you bring may go into the voting booth with you and help you vote. This person may be an election official, family member, friend, bystander, campaign worker or anyone else who is not your employer, agent of your employer, or officer or agent of your union. This is your right under federal law.

### **Non-English-Speaking Voters**

Most polling places within the Borough do not normally have bilingual assistance available. Let the Borough Clerk's Office know ahead of time if you will need this service and every effort will be made to provide it.

### **Physically-Disabled Voters**

If you have difficulty gaining access to your polling place, please let the Borough Clerk's Office know. We are making every effort to ensure that polling places are accessible to everyone.

### **Emergency Absences**

If you are unable to vote at your polling place on Election Day and did not have time to apply for an absentee ballot by mail, you may be able to vote by fax. Applications for voting by fax must be received by the Borough Clerk's Office no later than 5:00 p.m. Alaska Daylight Time (AKDT), Monday, October 2nd. See Pages 4 and 6 for more information.

# **Frequently Asked Questions (FAQ)**

Election Day is Tuesday; October 3rd Polls are open from 7:00 a.m. to 8:00 p.m.

**Who may vote in this election?** Registered voters of the Kenai Peninsula Borough 18 years of age or older.

**How old must I be to register to vote?** You may register anytime within 90 days immediately preceding your 18<sup>th</sup> birthday. If you are 18 years of age or older, you may register at any time. In order for your name to appear on the precinct register, you must be registered 30 days prior to the election.

**Where can I register?** You may register to vote at the Borough or any City Clerk's Office, public libraries, the Department of Motor Vehicles or online with the Division of Elections: https://voterregistration.alaska.gov.

**Do I have to register for each election?** No. If you are registered to vote in State elections, you are also registered to vote in local elections. Your registration remains active as long as you remain a voting resident of Alaska in good standing. You must, however, re-register if you change your residence to another jurisdiction.

### When are elections?

The Kenai Peninsula Borough and cities within the Borough hold regular municipal elections every year on the first Tuesday in October.

- > State primary elections are held in even numbered years on the fourth Tuesday in August.
- > State general elections are held in even numbered years on the first Tuesday after the first Monday in November.

**Who is eligible to vote in a Borough election?** Persons who are qualified to vote in State elections and have been registered to vote at an address in the Kenai Peninsula Borough for at least 30 days prior to the election.

**Where is my polling place?** See Page 2 of this pamphlet, or use the Division of Elections polling place locator: https://myvoterinformation.alaska.gov/ or scan the QR code for the Division of Elections interactive precinct map:



When are the polls open? Polls are open on Election Day from 7:00 a.m. to 8:00 p.m.

What will happen on Election Day if I am not registered in the correct district and precinct? You will be required to vote a questioned ballot. This procedure will be explained to you at the polls or you may contact the Borough Clerk's Office.

# How do I get an absentee ballot?

- ➤ You may vote absentee in person. Absentee voting begins approximately 2 weeks prior to the election. See Page 7 of this pamphlet for the start-up date and hours of operation.
- You may apply for a ballot to be mailed, faxed or emailed to you. Apply online at my.kpb.us/vote or use application provided on Page 4.

*I am disabled and cannot get to the polls. How can I vote?* You may apply for a ballot to be mailed to you as indicated above. For information on special needs voting, contact the Borough Clerk's Office or any City Clerk's Office in the borough.

*I am in the hospital. How may I vote?* For information on special needs voting or absentee voting, contact the Borough Clerk's Office or any City Clerk's Office in the borough.

What happens if I am in line to vote when the polls close? You will be allowed to vote if you are in line when the polls close.

What happens if I make a mistake on my ballot? If you make a mistake, fold and return the ballot to the official in charge. The ballot will be spoiled and destroyed and a new one will be issued to you. A maximum of 3 ballots may be issued.





#### Safe

The absentee ballot system is a safe way to cast your vote during the COVID-19 pandemic. You may apply for an absentee ballot and vote from home.



#### Convenient

Avoid lines and crowds at polling places. Absentee ballots are a quick and easy way to vote at your convenience in the weeks leading up to election day.



#### Secure

For over 20 years, absentee ballots have been a secure option for voting in Kenai Peninsula Borough (KPB) elections.

We have made no corrections for grammatical errors, spelling errors, punctuation or capitalization. Some minor formatting changes were made in order to fit the information in the space allotted.

In addition to the candidate information, the following pages also include proposition summaries that have been approved by the assembly and are strictly factual in nature. Statements advocating voter approval and rejections of the propositions are included as well. These statements have been received from the prime sponsor of the proposition and other individuals with a stated interest. KPB 4.10.110 (A) & (B).

Also included is a listing of service area board candidates and their contact information, if provided by the candidate. Feel free to contact your local service area board candidates. A map of each precinct and a copy of each of the ballots for the Regular Election is included in this pamphlet. The map key will direct you to the page or pages containing the city and/or borough ballot that voters residing in that particular area will receive on Election Day. Depending on where you live, your ballot may contain only a few races. Precincts with numerous races will have issues on both the front and back of the ballot.
