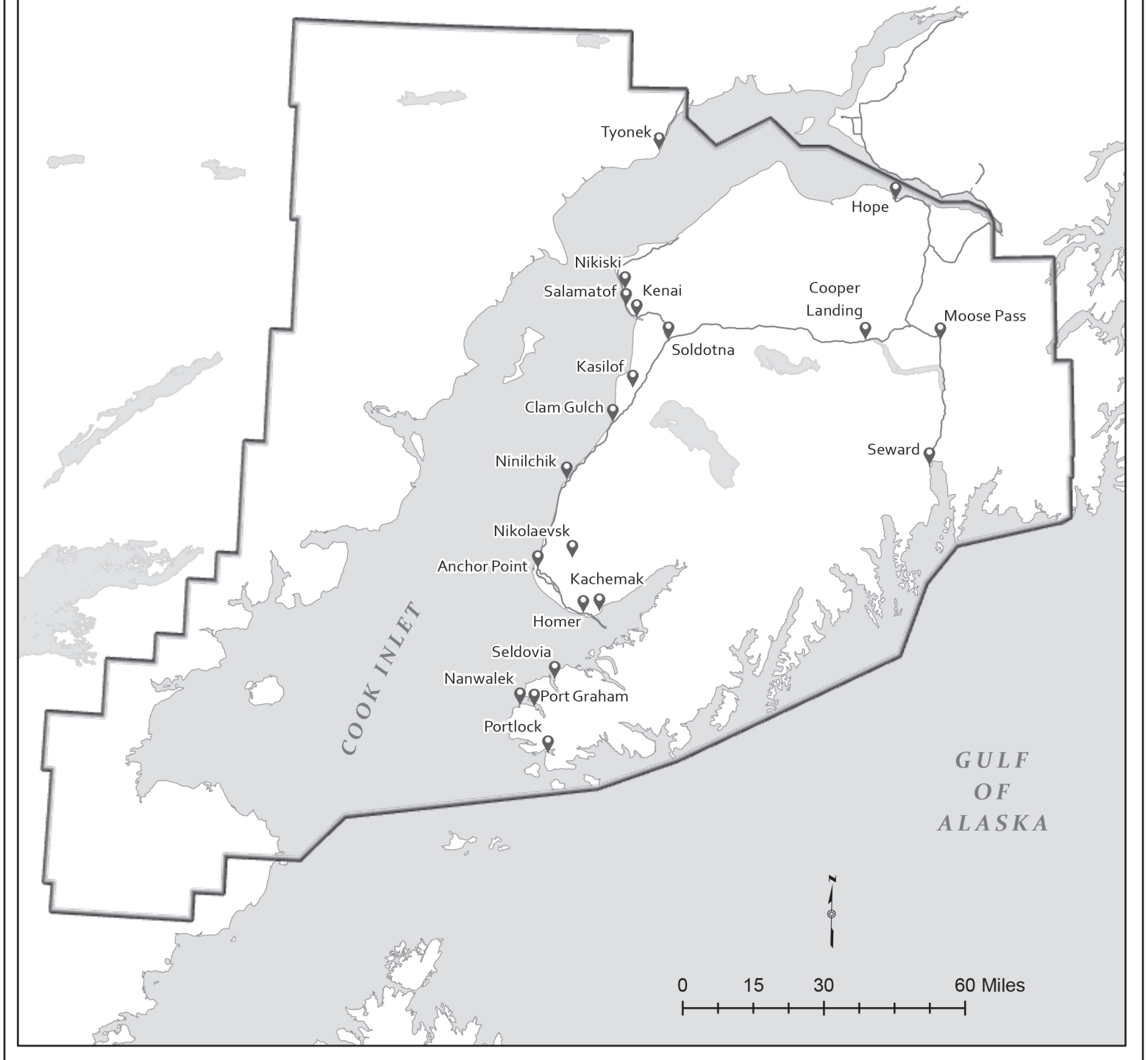

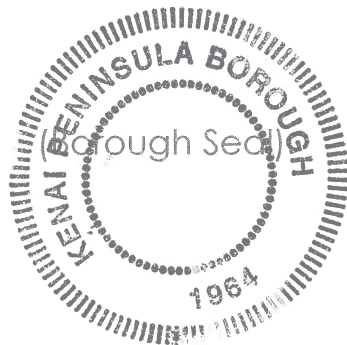

PROPERTY TAX FACT SHEET

A. PERSONAL PROPERTY:

Personal Property consists of items that are not permanently affixed to the land, such as watercraft, aircraft and heavy equipment.

Business Personal Property consists of items used to operate a business, such as desks, computer equipment, tools, restaurant equipment and store fixtures.

Owners of registered watercraft (20 or more feet in length) and/or FAA registered aircraft are required to file a personal property statement. Returns must also be filed by persons owning, having an interest in, holding, or controlling personal property with a total value greater than \$100,000 unless otherwise exempted from tax by Borough code. Returns must be filed for all personal property, including watercraft less than 20 feet in length, and aircraft located within the boundaries of an incorporated city, unless otherwise exempt from filing by both Borough and City code. Personal Property forms are mailed to all previous filers in **December** of each year.

All personal property statements must be filed with the Assessor's office by February 15 of each year. Property owners who fail to file by February 15 will be assessed a 10% late filing penalty plus 10% interest per year. Filing forms are available online or at the Borough building and City offices.

Registered watercraft and aircraft located in or normally kept within the Borough, but outside the boundaries of a city are taxed according to the flat tax table. Watercraft and aircraft normally kept within the boundaries of a city are taxed according to the flat tax table **and** according to the city code.

B. REAL PROPERTY:

Real Property is land and any improvement attached to the land (i.e., driveways, wells, houses, cabins, mobile homes, barns, shops, utility sheds, etc.). All Real Property improvements are physically inspected and valued by borough field appraisers. Physical inspections of Real Property are a year-round role of the Assessor's office and each field appraiser carries/displays a Borough photo ID card.

C. ASSESSMENT NOTICES:

Real Property Assessment Notices are mailed on or about March 1 of each year.

Personal Property Assessment Notices are mailed on or about March 15 of each year.

These assessment notices advise you of your current year property valuation. * If you disagree with the Assessor's valuation, you have **30 days from the mailing date** to file a written appeal to the Board of Equalization. Before filing a written appeal, it is to your advantage to discuss the valuation with a borough appraiser. It is the responsibility of the property owner to notify the Assessor of any omissions or errors in the assessment of your property.

* **Real Property values are established by comparing a property with similar properties having sold within the same market area. Alaska law requires the Assessor value all property at 100% of fair market value.**

D. TAX PAYMENTS:

Taxes are payable when billed. Payment in full is due on or before **October 15** and becomes delinquent thereafter. At the option of the taxpayer, taxes may be paid in two equal installments. If the taxpayer elects this option, the first one-half of the taxes must be paid on or before **September 15**. The second one-half taxes then become due on or before **November 15** and become delinquent thereafter. If the first one-half of the taxes payable are **not** paid by **September 15**, payment of the taxes in full becomes due on or before **October 15**.

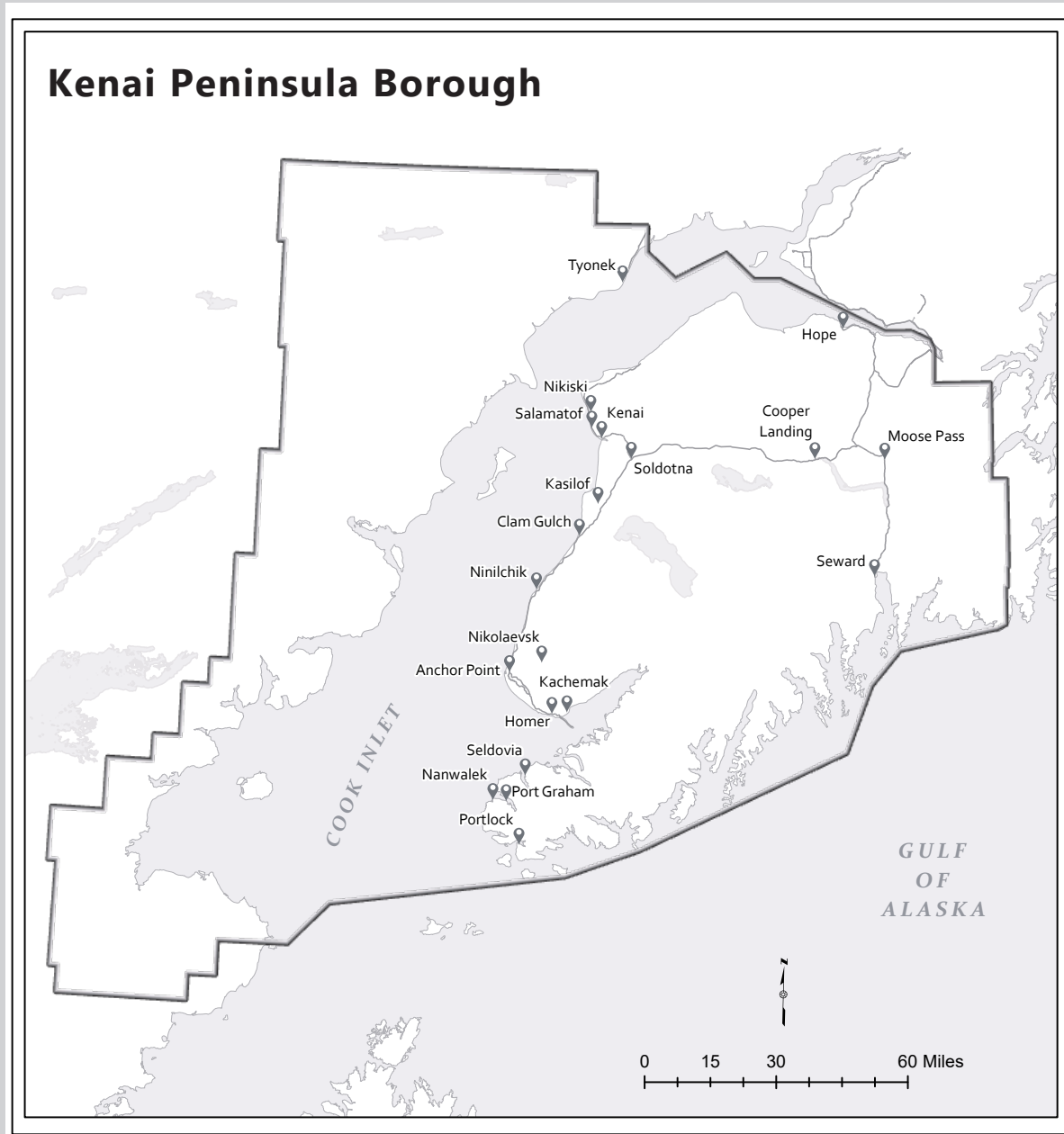
Penalty and interest are calculated as follows: Late payment penalty of 5% of the taxes due shall be added to all delinquent taxes on the day they become delinquent and additional penalty of 5% of the taxes due shall be added to any tax more than 30 days delinquent. Interest shall be calculated at 10% per year from the date that the taxes would have ordinarily come due in accordance with KPB 5.12.190(a).

IT IS THE TAXPAYER'S RESPONSIBILITY TO MAKE SURE THEY GET THEIR TAX BILL(S) AND PAY ON THE PROPER ACCOUNT(S). THIS ALSO APPLIES TO ANY EXEMPTION OR PERSONAL PROPERTY FILING FORMS.

EXEMPTIONS & DEFERMENTS:

1. **50,000 Exemption** – Requires a one-time filing. The first \$50,000 of assessed valuation of residential real property owned and occupied as the permanent place of residence in the Borough shall be exempt from the Borough tax levy on real property within the Borough.
2. **10,000 Volunteer Firefighter/EMS Exemption** – Requires annual filing. \$10,000 of assessed valuation of residential real property owned and occupied, as the permanent place of residence in the Borough by an active volunteer certified as a firefighter by DPS or emergency medical services provider by the State of Alaska shall be exempt from the Borough tax levy on real property within the Borough. (Maximum of 2 per household)
3. **Senior Citizen Exemption** – Requires a one-time filing for most residents -The first \$300,000 of assessed valuation of real property owned and occupied as the primary residence and permanent place of abode by a resident who is 65 years of age on January 1 of the tax year and eligible for the Alaska Permanent Fund Dividend. A surviving spouse who is 60 years of age may also qualify.
4. **Disabled Veterans Exemption** – Requires one-time filing. Real property owned and occupied as the primary residence and permanent place of abode by a resident who is a US veteran with a service-connected disability rated at 50% or more by the branch of the service in which they served. A surviving spouse who is 60 years of age may also qualify. Verification of disability rating must be submitted annually to retain this exemption.
5. **Disabled Resident Exemption** – Requires annual filing. Real property owned and occupied as the primary residence and permanent place of abode by a resident who has been determined, in writing, to be totally disabled by the US Social Security Program, the federal Civil Service System, the postal employees retirement system, the civil service retirement system of any state, the Alaska Public Employees Retirement System, the Alaska Teachers Retirement System or similar programs which are alternatives to participation in the US Social Security Act, shall be exempt from the Borough tax up to a maximum of \$500.00 of such tax.
6. **Community Purpose Exemption** – Requires a one-time filing. Property of an organization not organized for business or profit-making purposes and used exclusively for community purposes is exempt from taxation. Property or a part of the property from which rentals or income are derived is not exempt from taxation unless the income derived from the rentals does not exceed the actual cost to the owner of the use by the renter.
7. **Non-Profit Exemptions** – Requires a one-time filing. Property of an organization not organized for business or profit-making purposes and used exclusively for nonprofit religious, charitable, cemetery, hospital or educational purposes is exempt from taxation.
8. **Personal Property Exemption** - The first \$100,000 of personal property (excluding boats and planes) located in the Borough is exempt from tax. Personal property located within the boundaries of an incorporated city is subject to applicable city ordinances.
9. **Farm Deferment** – This allows the Assessor to value the land at farm use value. In order to qualify, the applicant must be actively engaged in farming the land and/or raising and breeding of livestock. At least 10% of yearly gross income must come from the farm use land. The application must be filed every year and is due on or before May 15.
10. **Conservation Easement** – Land that is encumbered by a conservation easement shall be assessed and taxed on the full and true value for use subject to the conservation easement. Applications must be filed with the Assessor each year on or before May 15.
11. **River Habitat Protection Tax Credit** – A tax credit of up to 3 years based on 50% of taxes levied on the land or up to the cost of the qualifying restoration project is available to taxpayers upon approval of their Kenai River Habitat Protection Project.
12. **River Renovation & Restoration Exemption** – A 4-year exemption for any increase in assessed value that is directly attributable to the alteration of the natural features of the land or new maintenance, repair or renovation of an existing structure. The alteration, maintenance, repair or renovation must enhance the exterior appearance or aesthetic quality of the structure and may only be granted to a property with an approved River Habitat Protection project.
13. **Vessel Exclusion** – A vessel may be excluded from the assessment roll if it is in the Borough solely for the purpose of repair, servicing or seasonal storage. This exclusion must be applied for by February 15. The vessel must be removed from the borough prior to July 1 of the year excluded.
